Financial support program

Genetic testing can be complicated. Paying for it shouldn't be. That's why Quest Diagnostics offers a financial support program. Upon receipt of a fully completed order, our team will verify coverage with your patient's health insurance plan and estimate their likely out-of-pocket responsibility. In the event that your patient's estimated out-of-pocket cost is greater than \$100 for all BRCA-related tests, we will notify you and/or your patient prior to test initiation to discuss options for continuation or cancellation of the test.

Please note that applications lacking complete information will not be processed.

For patients who require additional financial assistance, Quest Diagnostics offers payment plans of 0% financing for a 12-month period.

Genetic counseling

Genetic counseling is an important part of genetic testing. Many patients already have access to genetic counseling services through their primary healthcare provider. For those who don't, Quest Diagnostics will connect individuals considering genetic testing to a genetic counselor. Counselors will advise on indications for testing, limitations, risks, and options associated with testing, and they will help explain what the results mean for the patient and the patient's family.

Our genetic counselors are also available from 8:30 AM to 8:00 PM EST to help medical professionals with any genetic testing questions, including appropriate test selection and interpretation of results.

- For uninsured and underinsured patients whose household income is at or below the federal poverty level, testing is provided at no charge to those individuals
- Uninsured and underinsured patients who meet income requirements (household incomes of greater than 100% and at or less than 400% of the federal poverty level) may qualify for an out-of-pocket maximum of \$200 for eligible hereditary cancer tests
